



**MINUTES OF TENTH BIENNIAL CONVENTION OF ALL INDIA ESIC
SC/ST OFFICERS' & EMPLOYEES' FEDERATION HELD ON 3RD MAY,
2015 IN CONFERENCE HALL OF REGIONAL OFFICE, ESIC, NANDA
NAGAR, INDORE, MP.**

The First Session of Tenth biennial convention of All India ESIC SC/ST Officers' and Employees' Federation was held on 3rd May, 2015 in Anand Mohan Mathur Sabhagrah (Kunti Hall), Indore, M.P. Hon'ble Shri Mahendra Hardia, MLA and Former State Health Minister of Government of M.P. was Chief Guest of the occasion. Shri Bhagwan Das Godane, Former Chairman, Labour Welfare Board (MP) and Dr. R.S. Kureel, Director General, Baba Saheb Ambedkar Institute of Social Science, Ambedkar Nagar, MHOW (MP) were special guest of the occasion.

The tenth biennial convention began with celebration of 125th year of birth anniversary of Dr. B.R. Ambedkar. All dignitaries paid rich tributes to Baba Saheb Dr. B.R. Ambedkar and conveyed their blessing for strong Federation. The Tenth biennial convention was inaugurated by Hon'ble Shri Mahendra Hardia Ji the Hon'ble Chief Guest of the occasion.

The Second Session of Tenth biennial convention of All India ESIC SC/ST Officers' and Employees' Federation was held in Conference Hall of Regional Office, ESIC, Nanda Nagar, Indore, MP.

The Senior executives of the Federation were welcomed on stage. Subsequently, veteran activists of Federation were welcomed on stage. The house welcomed all the dignitaries by giving a welcome buckeye.

With the permission of chair the proceeding of meeting started. At the outset Shri Jalim Singh Ahirwal, Working President in his speech gave a brief description of functioning of the Federation. Shri Heera Singh, Secretary General presented final account of Federation for year 2011-12, 2012-13 and 2013-14 and informed that during this period collection were made as contribution and interest on balance in saving accounts. There is Nil Expenditure during all these years. At this member of Haryana Unit raised issue of non-receipt of payment receipt of Rs. 8,000/= which was paid by them on day of previous convention on 23-04-2011. The payment was not made to Secretary Finance of previous body as well as of the current body. The payment was made to convenor of the biennial convention hence the same was immediately spend on working arrangement of biennial convention then and there itself and the details of collection and expenditure was announced in the open house. The then outgoing Executive Body and host of convention in year 2011 and particularly Secretary Finance did not made any arrangement for collection of contribution and issue cash receipts. The cash receipt were not handed over the existing Executive Body even till today. In view of above those units which were willing to bear the expenditure have contributed directly to the Expenditure of hosting the convention of year 2011.

In view of above the house adopted the audited final accounts of the year 2011-12, 2012-13 and 2013-14 by voice vote.

The members of Regional Unit of Faridabad had raised the issue of non-conducting of executive committee meeting of the Federation even once. At this Shri Heera Singh, Secretary General informed the august house that the executive committee was not held for want of host region as none of the regions were willing to come forward for holding the Executive Meeting and hence the meeting of All India Executive Committee could not be held after 23-04-2011.

Shri M.G. Sorate, representative of Regional Unit of Maharashtra expressed his un comfort on the behaviour of some of the units he also raised the issue of lack of interest on functioning at central level for conducting the executive committee meeting. He demanded conducting of regular zonal and national EC meeting of Federation.

Shri Jalim Singh Ahirwal, Working President appraised the house regarding the family problems of Shri Heera Singh who had lost two of his family members in short span of just two year and non-the less the performance of Federation was

not bad as lot of serious issues were taken up with the management which are also prominently highlighted in official web site of our Federation.

In order to hold biennial election of the new executive body the name of Election Commissioner was called from among the members of General Council of delegates. A name of Shri Tara Chand Panwar was proposed and seconded by voice vote for smooth conduction of Election of new executive body.


After approval of proposal of nominating Shri Tara Chand Panwar as Election Commissioner the President declared the Executive Body as dissolved and the house was adjourned for a tea break.


After tea break the house again gathered and the election of Executive Body was conducted under the kind supervision of Election Commissioner. The House elected the executive body by voice vote as under :
