With due regard, I would like to submit that I have received an endorsement copy of representation of Shri Kuldeep Kumar, ECG Technician of ESIC Hospital Jhilmil regarding Harassment complaint against Shri Chaggan Jaagid which is addressed to A.C. (P & A).

In this regard, I would like to submit that Shri Kuldeep Kumar, ECG Technician is being harassed by some RWA members of staff quarters of ESIC Hospital Jhilmil, Delhi. The complainant has submitted some facts for elaborating the violation of staff quarters allotment rules against those officers for seeking action against them.

I would further like to submit that these people are harassing Shri Kuldeep Kumar by making false complaint against him and trying to get his higher type accommodation cancelled. The complainant was allotted higher type accommodation as per rule in 2011 and since then there was no requirement to vacate his accommodation.

quarters are abandoned by occupants for taking benefit of revised higher HRA rates hence showing haste in vacating these quarters will again result in surplus type D quarters. Hence, the complainant may not be insisted for vacating the quarter at this point of time.

Further to above, in case the situation compels it should be ensured that the Government servant should be allowed the option to change over their entitled type on the floor and area of his choice as per provision made in sub-rule 9 of rule 6 issued by the Directorate of Estates.
