Subject : Elevation and Extension of Corrupt officers on key Administrative post in ESIC – Request for reviewing the decision of allowing Extension to Shri T.K. Bhattacharya, Commissioner (P & A) after retirement.

Sir,

With due regard, I would like to invite your kind attention on my three letters having last number of 133 addressed to Hon'ble Prime Minister of India, 134 addressed to Hon'ble Minister for Labour and Employment GOI and and last number 135 addressed to Central Vigilance Commissioner on subject cited above. A copy of which had also been endorsed to you for your ready reference.

2. In this regard, I would like to inform you that I have received a very loose reply from your Director, Vigilance (**copy enclosed**). The letter says that the allegation made by me appears to be **general in nature** and **do not appear to be verifiable**.

3. The use of such loose words such as allegation are "general in nature" is very objectionable as allegation are very specific and is raised for against extension of a specific officer.

4. While analyzing the meaning of statement that all allegation are general in nature, I could understand only following two senses of use of this terminology and in both senses the statement is explaining a very uncomfortably position of ESIC in dealing with subject of corruption in big projects :-

- a) The first meaning of term "general in nature" that I could gather is that these type of complaints with very serious allegation with specific information against a specific officer is a general feature in ESIC and are received against all Sr. Officers. I am sure these kind of complaints are generally not leveled against all our Senior Officers by any genuine complainant.
- b) The second meaning of term "general in nature" that I could gather is that these allegation with specific information against a specific officer is known to every one in ESIC but since these are not verifiable, hence not actionable.

5. Sir, in any case I am made to believe from this reply that corruption in ESIC has become general in nature. Those public officers who are appointed to act as watch dogs over public funds and are holding lot of substantive information and has got procedure to call for relevant records are seeking these information from those sources which are generally not supposed to hold these information.

6. Sir, this reply has reminded me of one such similar instance, the facts of which are very relevant to the occasion. In year 2011, I was attending a meeting with one of Senior Officer of ESIC for discussing issue of discriminatory transfer and posting of our members. The main issue being discussed was that members of our fraternity were selectively choosed and picked for uncomfortable places. Since, the members were neither longest stay case nor they were junior most, their selective posting was opposed strongly. I also raised issue that these wrong transfer were done by your administrative officer by accepting premium whiskey bottle as bribe. That Senior Officer immediately responded by stating that it is general thing in ESIC. I was stunned by his reply and I instantly protested and he immediately rectified himself and told that he was just joking.

7. Unfortunately , this time I have received a same reply in writing and I feel deeply hurt by this reply.
