**Subject : Elevation and Extension of Corrupt officers on key Administrative post in ESIC – Request for reviewing the decision of allowing Extension to Shri T.K. Bhattacharya, Commissioner (P & A) after retirement.**

Sir,

With due regard, I would like to invite your kind attention on my three letters having last number of 133 addressed to Hon'ble Prime Minister of India, 134 addressed to Hon'ble Minister for Labour and Employment GOI and and last number 135 addressed to Central Vigilance Commissioner on subject cited above. A copy of which had also been endorsed to you for your ready reference.

2. In this regard, I would like to inform you that I have received a very loose reply from your Director, Vigilance (**copy enclosed**). The letter says that the allegation made by me appears to be **general in nature** and **do not appear to be verifiable**. The use of such loose words such as allegation are "general in nature" is very objectionable as allegation were very specific and were raised against extension of a specific officer.



3. However, to my utter surprise, I got to know from official website of ESIC that in spite of removing corrupt officer Shri T.K. Bhattacharya, Commissioner (P & A) who has intentionally failed to withhold his duties and who is still misusing his position, the management of ESIC had considered to transfer Shri B.K. Sahu, Insurance Commissioner who is the senior most in the grade from post of Insurance Commissioner to Insurance Commissioner NTA. Here, I would like to submit that the number of post of Insurance Commissioner sanctioned in ESIC is only one and the order No. 28 of 2013 envisage for posting of two Insurance Commissioners which is also in itself unconstitutional.


4. It is further submitted that the ESIC officers' association working in different regions of ESIC are facing strong revolt from groups within it who are raising strong voice against the corrupt regime which has with the aid of external forces not only spoiled the platform of Officers Federation but also the functioning of ESIC. I am made to believe that this hurriedly passed order is an attempt to sabotage this movement and to favour those officers who are believed to be deeply involved in cases of corruption.

5. Our Federation strongly oppose such actions which are not aimed towards public interest but are infected from manifestation of manipulating the Government machinery to the advantage of some corrupt officers by ignoring public interest. Simultaneously, it is an attempt to harm the democratic set up of Officers' Federation. We the federation of SC/ST Officers and Employees of ESIC strongly oppose such rash decisions taken by the Management to manipulate the functioning of service associations.

6. In view of above, it is my humble submission that the decision of granting extension to Shri T.K. Bhattacharya, Commissioner (P & A) may also be revisited at the earliest as this is bringing bad reputation to ESIC as well as to our Government. You are also requested to put on hold the decision of transferring Shri B.K. Sahu, Insurance Commissioner till the new Officers Association of ESIC Headquarters Office takes charge.

7. Further to above, you are requested to kindly issue directions to hold enquiry against the erring officers who have failed to bring all facts to the knowledge of Union Cabinet Minister for Labour and Employment while submitting the proposal for post retirement extension of Shri T.K. Bhattacharya, Commissioner (P & A).
