Respected Sir,

With due regard, I would like to invite your kind attention on my earlier letter No. AIESIC.SC/ST.FED/2015/005 dated 17th June, 2015 copy enclosed as Annexure – I addressed to the Director General, ESIC in which I have raised issue of Violation of transfer and posting policy of ESIC with respect to Officers of Group A – A case of Shri Tri Rattan, Assistant Director (OL), SRO, Okhla. The enclosure is self explanatory.

This letter was pursued by my another letter of even number dated 17th September, 2015 copy enclosed as Annexure – II to the Director General, ESIC. No action was taken by the Director General, ESIC on my above both letters. Unfortunate the management do not have even curtsey of acknowledging the letter of our platform. Management have not taken any remedial action in the matter.

In view of inaction on the part of Management the matter was taken up with your good office vide my letter No. AIESIC.SC/ST.FED/2015/005 dated 13<sup>th</sup> Oct., 2015 copy enclosed as Annexure – III. In this letter I had requested your good office to bring

parity between SC officer and others. The General Category Officer Assistant Director (Official Language) who had in his entire career served in NCR was posted on promotion in NCR. Whereas an officers of SC category who was given initial posting in Chennai for a tenure of eight years had after just completing four years in NCR again on promotion been posted out to Kolkatta. Never in History of ESIC the just principle of First Come First Go was followed, which resulted in "Ghar Chodo aur Bharat Darshan Karo" transfer/posting for SC/ST officer. Where as to the contrary for the General Category Officer and Corrupt Officers it is "Bharat Chodo aur Ghar ke Darshan Karo". The officers are accomodated in their convenient place for illegal consideration.

I am using this occasion for bringing this to your kind information with a hope that you will definitely do something so that the proper justice is given to our aggrieved officers and issue direction to Director General, ESIC to adjust our officer and allot posting on the basis of principle "First Come First Go".
