After waiting for long these officers are repatriated and after service of few years they are again made subject to extreme posting on promotion.

In view of above, on behalf of my Federation I would like to request you to kindly take cognizance of all past posting of SSOs while deciding their present posting as Assistant Director and the Principle of "First Come First Go" must be followed rigorously.
