 - d) for NTA - 03
2. The Administration of ESIC had recently issued an Office Order No. 106 of 2017 dated 05-06-2017 thereby promoting only 24 officers to the post of Additional Commissioner and leaving one post unfilled for unjustified reasons.

The mandate of DPC (Screening Committee) was to draw a penal of 25 officers for promotion for the post of Additional Commissioner and the DPC Screening Committee failed on its mandate by recommending only 24 officers for adhoc promotion inspite of the fact that two eligible officers of SC category were available for promotion and the applicant being one of them.
4. From this order it is clear that the Administration of ESIC must have given false or frivolous information to DPC (Screening Committee and thereby caused DPC (Screening Committee) to use his lawful power to the injury or annoyance of a member of Scheduled Caste Member.
5. Here, it is pertinent to mention that the Administration of ESIC had intentionally insulted or intimidated with intent to humiliate a member of a Scheduled Caste in public view by their this conduct and publishing the Office Order No. 106 of 2017 on official web site of ESIC (www.esic.nic.in).
6. It is also pertinent to mention here that the Administration of ESIC had resorted to committing criminal offense against SC/ST Members which can never be compromised.

In view of above, on behalf of my Federation I would like to request you to kindly take following actions for betterment of ESIC :

- 1., Immediate removal of Shri K.G. Suresh, Joint Director, Establishment from Headquarters.
