Information

A reliable information has been received to the effect that Shri R.ThineshKumar, I/c. Joint Director, Employees State Insurance Corporation (ESIC), Sub Regional Office (SRO), Madurai entered into a criminal conspiracy with Shri K Rajamohan, of E M G Yadava Women's College Madurai and in pursuance of the same, Shri. R.Thineshkumar allowed EMG Yadava Women's College to delay the payment of outstanding dues to ESIC and also assured waiver of damages and for this official favour, demanded illegal gratification.

- 2. Information further revealed that in the matter of three ESI cases pertaining to M/s. E.M.G. Yadava Women's College, Thiruppalai, Madurai, damages to the amount of Rs.7 lakhs was to be levied for non-payment of ESI by E.M.G Yadava Women's College Madurai besides interest payment of Rs. 4 lakhs. Shri Thineshkumar, I/c. Joint Director, ESI, Madurai with fraudulent intention to help Sri. Rajamohan of M/s E.M.G Yadava Women's College assured them of waving Rs.7 lakhs damages levied on the said college and for this act Shri Rajamohan was directed to meet Shri R.Thinesh Kumar on 31.10.2017 to hand over the illegal gratification for extending the said favour. It is reliably learnt that Shri Raja Mohan would be meeting Shri Thinesh Kumar, I/c. Joint Director, ESIC, SRO, Madurai on 31.10.2017 at around 2 PM for handing over the illegal gratification directly.
 - 3. The above acts of Shri R Thinesh Kumar, Incharge, Joint Director, ESIC, Madurai and Shri K Raja Mohan, representative of M/s. E. M. G. Yadava Women's College, Thiruppalai, Madurai and other unknown public servants and others prima-facie constitute the commission of offences punishable U/sec. 120-B IPC r/w Sec 7 & 8 of Prevention of Corruption Act, 1988. Hence, a Regular Case has been registered as per the orders.
