

In spite of verbal commitment made by DG, ESIC for getting the matter of conveying DPC for year 2016-17, 2017-18, 2018, 2019 examined through DoP&T for considering the adhoc service against regular vacancy as regular for purpose of promotion in view of various Supreme Court decisions, no action has been taken in the matter by either Administrative Ministry or ESIC. Apart from this, other matters which were clearly agreed by DG, ESIC in hearing are also not done on flimsy grounds.

The action in the matter has been kept pending since 09-05-2019 and on the other hand Shri K.G. Suresh, Joint Director (Establishment Branch – I) who is responsible for conducting DPC of Group A and B Officers is devoting his whole energy in processing his own case for promotion for the post of Regional Director Gr. A/Director against the vacancy year 2020 well in advance even though his case is suffering from following anomalies.

- 1) He is also anticipating to seek benefit of failing clause in RR of Reginal Director Gr. A/Director which was treated as anomalous in case of RR for the post of Regional Director Gr. B/Joint Director.
- 2) He has devoted his whole energy for stopping process of notifying of amended RR for the post of Regional Director Gr. A/Director as he was adversely affected by new proposed RRs.
- 3) He is also anticipating to seek benefit of getting relaxation of two years as junior to him are eligible under failing clause.
- 4) He has been appointed to the post of Deputy Director against panel for recruitment year 2002-03.
- 5) He has joined to the post of Deputy Director on 14-06-2004 in recruitment year 2004-05.
- 6) He was wrongly allowed seniority against year 2002-03.
- 7) The DPC meeting is not conveyed for post of Regional Director Gr. 'B'/Joint Director, Deputy Director and Assistant Director since last six years
