With due regard, I would like to invite your kind attention on Office Order No. 66 of year 2018 dated 14-05-2018, a copy of which is enclosed herewith for your perusal please.

In this regard, I would like to submit that Shri R.K. Kaim, Director, Directorate of Medical Delhi inspite of having adverse compelling family conditions had completed his out posting in SRO Vadodhara for a period starting from 22-08-2014 to 05-06-2016.

After completion of his tenure in SRO Vadodhara, he was repatriated on promotion to the post of Director and joined in Directorate Office Medical Delhi and had not even completed his present spell of tenure and had again been transferred out of Delhi NCR to RO, Assam. It clearly bears signs of discrimination on Caste basis.

From above table it can be easily gauged that a total of five officers of the rank of Director and above are going to retire from Headquarters Office in current financial year out of which two officers are going to retire in the month of May and June of this year. It clearly indicate requirement of five officers in Headquarters Office in this financial year. In such a scenario if one officer of SC category is transferred out of Delhi, it clearly gives indication that the decisions are not being taken on genuine grounds but unreasonable ground of caste and creed.

In view of above, you are requested to kindly cancel the transfer of Shri R.K. Kaim, Director, Directorate Office Medical Delhi immediately.
