List of the Members who attended the meeting at Annexure-I.

At the outset, the Director General, ESIC welcomed the Hon'ble Minister for Labour & Employment/Chairman, ESIC and all the members of the Corporation.

While addressing the members, Hon'ble Chairman stated that he is attending the meeting of Corporation for the first time after assuming the charge of MoL&E. Hon'ble Chairman, stated that as per his knowledge minimum two meetings of the Corporation should necessarily be conducted annually but it should be done as frequently as possible for the welfare of the IPs on need basis. He also informed the House that Hon'ble Prime Minister has special interest on the ESI Scheme and advised to take the Scheme to all the districts of the country. Chairman, ESIC appreciated that the ESI Schemes caters to around 10% population of the country. While introducing the agenda items, he invited the members for detailed discussions for betterment of ESI Scheme.

On behalf of employees, Shri R.K. Tripathi welcomed the Chairman in his first meeting of Corporation and reiterated his achievements during his earlier assignment in MoL&E, MoS(Textiles) and MoS (Finance).

On behalf of employers, Shri Sudarshan Sareen also welcomed the Chairman & wished that under his dynamic leadership, the Corporation will achieve many more milestones.

Shri ChandraKant Khaire, Hon'ble M.P while welcoming the Chairman remembered his long association with him. He suggested for holding Corporation meeting every three months. He mentioned -

that a lot of work is required to be done in relation to the capital construction projects and also emphasized for opening of ESI District offices.

Shri C.P. Singh stated that a right should be provided to Corporation members for placing an agenda relating to the welfare of the IPs. Shri C.P. Singh said that he raised many IPs related issues but none of these have appeared on the agenda list. He further suggested that the speech delivered by the Chairman, ESIC should be circulated to all members of the Corporation. Shri C.P. Singh and Sh. Vijay Kalantri stated that after spending lots of money on construction of the Medical Colleges, it is not proper to handover these to the State Governments. Shri C.P. Singh mentioned that in view of the decision of High Court we should not amend ESI Act and instead we should build our capacity to run these colleges properly. He suggested for calling a meeting with Pharmacist Federation to resolve the issues relating to their promotional avenues.

Shri Dalip Bhattacharya expressed his concern over the circular issued by the Hqrs. relating to eligibility condition of two years for SST treatment of the IPs. He also stated that there are issues with ESI Act, 1948 Section 58, 59 and 59-A which should be resolved.

111 1 It is submitted that MoL&E vide their letter No. A-12034/07/2016-SS.I dated 10.11.2016 had directed the ESIC to send a proposal for amendments in RRs for the post of Regional Director Grade 'A'/Director to the Ministry in consultation with UPSC.

Accordingly, an Agenda Item in the 172nd meeting of ESI Corporation held on 6.12.2017 regarding amendments in the RRs for the said post was placed for approval under L Item No. ESIC 22.

We have received minutes of the said meeting duly approved by the Chairman, ESI Corporation vide Corporate Cell letter No. V-11(15)-1/2017-Corporate Cell dated 16.1.2018 (PUC). As per the minutes ESIC has approved the proposal for amendments in the RRs of the said post.

As per sub-section (1) of section 97 read with clause (xxi) of sub-section (2) and sub-section (2A) of that section and Section 17(2) of the ESI Act, 1948 the ESI Corporation has been conferred power to make regulations regarding the method of recruitment, pay and allowances, discipline and other conditions of service of the members of the staff of the Corporation in accordance with the rules and orders applicable to the officers and employees' of the Central Government drawing corresponding scales of pay. Only in case of departure from the said rules and orders, the prior approval of the Central Government is required under proviso clause of section 17(2) (a) of the Act. The revised proposed RRs of the aforesaid post have been prepared as per extant DoP&T instructions on framing of RRs. Hence prior approval of the Central Government is not required,

We may, now forward the proposal for amendments in the RRs for the aforesaid post to the UPSC for approval under Section 17(3) (1 he FSI Act, 1948 under intimation to the MoL&E.

I am directed to state that the MoL&E vide their letter No. A-12034/07/2016-SS.I dated 10.11.2016(copy enclosed) had directed the ESI Corporation to send a proposal to the Ministry for amendments in the recruitment regulations for the post of Regional Director Grade 'A'/Director in consultation with UPSC. The ESI Corporation in its 172nd meeting held on 6.12.2017 has approved the amendments in the Recruitment Regulations for the said post as per the seventh CPC recommendations.

As per sub-section (1) of section 97 read with clause (xxi) of sub-section (2) and sub-section (2A) of that section and Section 17(2) of the ESI Act, 1948 the ESI Corporation has been conferred power to make regulations regarding the method of recruitment, pay and allowances, discipline and other conditions of service of the members of the staff of the Corporation in accordance with the rules and orders applicable to the officers and employees of the Central Government drawing corresponding scales of pay. Only in case of departure from the said rules and orders, the prior approval of the Central Government is required under proviso clause of section 17(2) (a) of the Act. The revised proposed RRs of the aforesaid post have been prepared as per extant DoP&T instructions on framing of RRs. Hence prior approval of the Central Government is not required.

It is certified that no court case is pending regarding amendments in RRs for the aforesaid post.

Further, in compliance of the DoP&T OM No. AB-14017/61/2008-Estt. (RR) dated 13.10.2015, draft RRs of the posts were put up on the official website of ESIC vide Memorandum No. A-12(11)3/2015-E.I. dated 3.3.2017, for seeking comments of the stakeholders within 30 days of the issue of the Memorandum. After scrutiny, the proposal was returned in original with some observations which are examined as under:-



As in the pre-revised RRs for the post of Regional Director Grade 'A'/ Director, there is provision for two years minimum qualifying service as Regional Director Grade 'B'/Joint Director under failing which clause, similar provision is proposed in the revised RRs for the post.

It is pertinent to mention here that in Indian Revenue Service (Customs and Central Excise) Group 'A' Rules, 2016 (copy enclosed), for the post of Principal Commissioner of Customs and Central Excise (Grade III) (Higher Administrative Grade) for promotion to the post three years regular service in the immediate feeder grade under primary clause and combined service of twenty five years in Group 'A' posts in the service out of which one year service in the immediate feeder grade has been provided.

In view of the above, the Commission is requested to approve the RRs for the post of Regional Director Grade 'A'/Director as per approval of the ESI Corporation.







The queries raised by the UPSC in this regard vide their observation slip dated 30.1.2018 were replied vide ESIC letter dated 21.2.2018. In this context to further discuss the proposal with regard to 'combination of service' proposed by ESIC in the field of promotion for the post, a meeting between the officers of ESIC [attended by Shri K.G. Suresh, Joint Director-I and Shri Manish Gupta, Deputy Director (DPC)] and UPSC was held on 21.3.2018, as desired by the Commission vide their letter dated 16.3.2018 - 8669
