#### Large Scale Corruption in ESIC.

Respected Sir,

With due regard, I would like to invite your kind attention on enclosed news clippings dated 30-01-2021 published by Jagran, the Tribune and Outlook Newspapers on above captioned subject and to submit as follows (**Annexure-A to C**):-

- 1. This has been the second occasion in which CBI nabs Incharge of one the Sub-Regional Offices i.e. Director ESIC Regional Directorate Jammu in bribe case.
- 2. We are regularly receiving feedback that the ESIC Group A Officers' Welfare Association is well entrenched in Establishment and Vigilance Branches of ESIC and is corruptly influencing policy decision of ESIC with respect to promotion, transfer and vigilance matters. The members of this Association are being posted in strategic and sensitive locations without examining their past track record.
- 3. Some of the officers having bad track records or are charge sheeted are posted in sensitive positions. It has come to our notice that members of this Association are often meeting in Room of Shri Bhupender Kumar, Deputy Director DPC Cell and discussing and monitoring the placement and collection of from field offices on alternate day basis.

- 4. It has also been brought to our notice that one such officer of Corporation deployed in Administrative Ministry i.e. Ministry of Labour and Employment is also using his position in Administrative Ministry for influencing the decisions of Corporation in matter of promotion, transfer and vigilance action.
- 5. Shri P.B. Mani, Insurance Commissioner (P&A) is also tacitly providing shield to these corrupt officers.
- 6. I have written nearly a half a dozen complaints on similar matters, on which action is still kept pending by the authorities in ESIC and authorities in Administrative Ministry.
- In this regard, I would like to invite your kind attention on my letter F.No.AIESIC.SC/ST.FED.2015-039 dated 07-12-2017 on subject "Gross violation of Section 17 Sub-Section 3 of ESI Act, 1948 while making officiating or temporary appointment against the post of Joint Directors I/c by posting Deputy Director I/c in SROs without consultation of UPSC and violation of ESIC Revenue Manual in SRO Nandnagri". <u>Annexure - D.</u>
- 8. In this letter I have objected against posting of Deputy Directors having service length of just 6 years as In charge of SROs by making officiating appointment against the post of Joint Directors I/c for which minimum qualifying service required is 10 years from DD and 12 years from combined service of AD and DD. It was also done in violation of Section 17 Sub-Section 3 of ESI Act, 1948 by bypassing the requirement of consultation of UPSC.
- 9. Charge-sheeted Officer Shri M. George, Joint Director was given sensitive posting in SRO Marol, inspite of adverse direction of the then DG for his being involved in shabby activities with copies of noting of files as proof of allegation. In place of keeping him in non-sensitive position, he is again positioned in mainstream Administrative post of Joint Director (Estt V) as disciplinary officer of Group C and D in HQrs.
- 10. I have also raised similar issue of Shri R. Thinesh Kumar, Deputy Director I/c, SRO Madurai who was also caught red handed by the CBI accepting bribe of Rs. 15,000/- to delay the payment of outstanding dues to ESIC damages and for this official favour, apprehended officer demanded illegal gratification. A copy of FIR (Under Section 154 Cr.PC) is enclosed as <u>Annexure-E</u>.
- 11. In Sub Regional Office, Nandnagri, Shri Rajiv Lal the then DD I/c was also delaying the payment of outstanding dues to ESIC by fixing instalment during hearing afforded to employers under Section 85 (B) by violating official procedure. Copies of some of such decisions were provided with the letter. The file in which the matter was dealt is also reported to have gone missing.

In view of above, and in the interest of probity following actions are warranted in ESIC :

- 1. Removal of Shri P.B. Mani, IC (P&A) and Shri Bhupender Kumar, DD (DPC Cell) from sensitive post of Administration.
- 2. Review of all posting on sensitive positions and in particular in following positions:
  - a) Postings in Admin and Vigilance in Hqrs. Office,
  - b) Postings in Filed Offices i.e. RO and SRO as In charge.
  - c) Postings in those offices in which additional allowance are available out of such postings.
- 3. Immediate withdrawal of all officers who are deployed in Administrative Ministry, i.e. Ministry of Labour and Employment as they are main cause of corruption in ESIC.
- 4. Action may be initiated on my letter F.No.AIESIC.SC/ST.FED.2015-039 dated 07-12-2017 and responsibility of guilty officers should be fixed for not acting on this sensitive letter.

New Delhi, January 30

The CBI today arrested deputy director of the Employees' State Insurance Corporation (ESIC) Darbara Singh, who is posted at the department's regional office in Jammu, for accepting a bribe of Rs 50,000 to help the complainant in lowering a penalty amount from Rs 23 lakh.

Singh, who is also in charge Regional Director of Jammu, was nabbed on a complaint of a private security firm employee and the owner, who had received a notice from the ESIC office for improper papers, CBI spokesperson RC Joshi said.

"On knowing this, the complainant and the owner visited the office of the ESIC to meet the deputy director. Singh allegedly told the complainant that their papers were not proper and the ESIC would impose a penalty of Rs 23.9 lakh on them. He also said if they would pay him a bribe of Rs 2 lakh, he could reduce the penalty amount," said Joshi, adding after negotiation, they were told to pay the bribe in four installments of Rs 50,000 each. — TNS

# CBI arrests ESIC Jammu office deputy director while taking bribe

New Delhi, Jan 30 (PTI) The CBI has arrested the Deputy Director of the Jammu regional office of the Employees' State Insurance Corporation for allegedly receiving a bribe of Rs 50,000 for helping lower a complainant's penalty amount from Rs 23 lakh, officials said Saturday.

Darabara Singh, who is also in-charge Regional Director, was nabbed on a complaint of a private security firm employee and the owner who had received a notice from ESIC office for improper papers, they said.

"On knowing this, the complainant and the owner, both visited the office of ESIC to meet Deputy Director. During the meeting, the Deputy Director, ESIC, allegedly told the complainant that their papers were not proper and ESIC would impose a penalty of Rs 23.90 lakh on them and if they would pay him bribe of Rs 2 lakh, he can reduce the penalty amount," CBI Spokesperson RC Joshi said.

After negotiation, they were told to pay the bribe in four installments of Rs 50,000 each, he said.


The CBI acted on the complaint and laid a trap where Singh was caught red-handed receiving the bribe installment, Joshi said.

"Searches were conducted at the premises of accused in Chandigarh, Mohali & Jammu which led to recovery of cash of Rs 7 lakh and documents related to properties," he said. PTI ABS TIR TIR

The consultation of UPSC was further required as the officers concerned were made to exercise the financial and administrative powers as per the delegation of powers conferred to Joint Director (I/c) as per the combined booklet of delegation of powers 2005.
- 4. This Order was further in violation of Criteria laid down for Deployment of Group 'A' Officers in (Non-medical) posts which clearly prescribes that the relevant SROs will be headed by an officer of the level of Joint Director vide Memorandum No. B-11/11/1/11-E.III. dated 01-12-2011 enclosed as <u>Annexure - C</u>.
- The Competent Authority was kept in darkness and UPSC was not consulted only because there was a malafide intention of placing known DR officers on strategic positions whereas the Recruitment Rules for the post of Joint Director was against the Directly Recruited Officers.

- The employer should be required to furnish Bank Guarantee for the timely payment of monthly instalment.
- Employer should undertake to pay the current dues of the Corporation within the prescribed time limit.

#### Information

A reliable information has been received to the effect that Shri R.ThineshKumar, I/c. Joint Director, Employees State Insurance Corporation (ESIC), Sub Regional Office (SRO), Madurai entered into a criminal conspiracy with Shri K Rajamohan, of E M G Yadava Women's College Madurai and in pursuance of the same, Shri. R.Thineshkumar allowed EMG Yadava Women's College to delay the payment of outstanding dues to ESIC and also assured waiver of damages and for this official favour, demanded illegal gratification.

2. Information further revealed that in the matter of three ESI cases pertaining to M/s. E.M.G. Yadava Women's College, Thiruppalai, Madurai, damages to the amount of Rs.7 lakhs was to be levied for non-payment of ESI by E.M.G Yadava Women's College Madurai besides interest payment of Rs. 4 lakhs. Shri Thineshkumar, I/c. Joint Director, ESI, Madurai with fraudulent intention to help Sri. Rajamohan of M/s E.M.G Yadava Women's College assured them of waving Rs.7 lakhs damages levied on the said college and for this act Shri Rajamohan was directed to meet Shri R.Thinesh Kumar on 31.10.2017 to hand over the illegal gratification for extending the said favour. It is reliably learnt that Shri Raja Mohan would be meeting Shri Thinesh Kumar, I/c. Joint Director, ESIC, SRO, Madurai on 31.10.2017 at around 2 PM for handing over the illegal gratification directly.

3. The above acts of Shri R Thinesh Kumar, Incharge, Joint Director, ESIC, Madurai and Shri K Raja Mohan, representative of M/s. E. M. G. Yadava Women's College, Thiruppalai, Madurai and other unknown public servants and others prima-facie constitute the commission of offences punishable U/sec. 120-B IPC r/w Sec 7 & 8 of Prevention of Corruption Act, 1988. Hence, a Regular Case has been registered as per the orders.
