Subject: Request for Observing of laid down Directions/ Measures issued by Hon'ble Minister of State, Ministry of Labour and Employment, GoI and ESIC in view of COVID 19 Pandemic – for cancelling transfer of Mr. V. Srinivasan, UDC of the Tamilnadu Region and Large Scale Corruption in Transfer and Posting.

Respected Sir,

1. With due regard, I would like to invite your kind attention on enclosed policy direction dated 20.05.2020 of Hon'ble Minister of State (Independent Charge), Ministry of Labour and Employment, Government of India directing "that no rotational transfers of officers / officials in different grades (Group 'A', 'B' and 'C') be carried till 30.04.2021 in Ministry of Labour and Employment, ESIC, EPFO, CLC(C), DGLW, VVGNI, DGMS, DGFASLI, Labour Bureau etc" and "consideration of request by officers/staff on compassionate grounds i.e. medical emergency with self or family members etc." (**Annexure – I**).

2. In view of policy direction of Hon'ble Minister of State (Independent Charge) to ESIC many of the transfer posting had been either cancelled or deferred and many transfers are ordered on compassionate grounds. But the same has not been followed in the case of SC/ST employees and officers.

3. In view of direction of Hon'ble Minister of State and ongoing COVID 19 Pandemic, I submitted a distress call case of Mr. V. Srinivasan, UDC of the Tamilnadu Region vide my enclosed letter 02-07-2020 (**Annexure – II**) addressed to Additional Commissioner & Regional Director (AC & RD), Regional Office (RO), Chennai requesting him for cancelling transfer of Mr. V. Srinivasan, UDC of the Tamilnadu Region and releasing of his salary as per instruction enclosed.

4. Since, the policy direction was not followed by AC & RD, RO - Chennai, one more letter dated 16-07-2020 was written to the Director General (DG), Employees' State Insurance Corporation (ESIC), New Delhi requesting them to take remedial action. A copy is enclosed as **Annexure - III**.

5. The request of Mr. V. Srinivasan, UDC consists of following facts:

1. The applicant Mr. V. Srinivasan, UDC was recently posted from SRO Madurai to SRO Coimbatore.
2. I am made to understand that the officials at Sr. No. 1, 2, 6, 7, 14, 15 and 16 of transfer Office Order No. 48(E) of 2020 dated 28-02-2020 were considered for retention at their present place of posting/nearest place in view of Pandemic COVID – 19.
3. Whereas, Mr. V. Srinivasan, UDC has not been considered for retention at SRO Madurai and was also directed to join duty at new place of posting at the earliest.
4. I am also made to understand that Mr. V. Srinivasan, UDC is suffering from Neuro Problem and is undergoing treatment from Meenakshi Mission Hospital, Madurai, he is the only earning member in his family and have to look after his aged & widowed dependent mother, wife and two daughter one of whom is a newly born baby.

6. I am sorry to say that in spite of raising the issue before the Director General the aggrieved person has not been provided any kind of relief. Rather he was forcefully made to join his present place of posting.

7. In continuation of this action the General Secretary of our Regional Association of Tamilnadu was also removed from Regional Headquarters in vengeance. The conduct of Regional Administration had been grossly discriminatory and violative of all norms in this case also.

8. In view of above, I am also compelled to bring following obnoxious administrative conduct of Management of Regional Office, Tamilnadu conducted in past :-

- i) Deputy Director (Admn) in connivance with General Union of Tamilnadu Region influenced the election of Union by issuing discriminatory transfer posting.
- ii) Shri K. Santhamuthuvel, UDC was transferred from Branch Office Vellore to Branch Office Arakkonam nearly 90 Kms away by ignoring following facts :
 - a) He is a highly decorated para sports person of ESIC winning 4 Gold Medals in Discuss Throw, 3 Gold Medals in Short put in the events held in Thailand, Nepal, Srilanka and Malaysia respectively after joining ESIC.

- b) He have been felicitated by Hon'ble President of India for his marvelous achievements.
 - c) He is physically challenged person.
 - d) He is a member of Scheduled Caste Category.
- iii) Shri A. Arulprasath, Assistant was transferred from ESIC Hospital, K.K. Nagar to Branch Office Kodambakkam in spite of fact that his wife is working in ESIC Hospital, K.K. Nagar. Co-incidentally the Branch Office Kodambakkam was later on shifted to premises of ESIC Hospital, K.K. Nagar resulting in resolving of grievance of Shri A. Arulprasath, Assistant. In order to cause harassment to Shri A. Arulprasath, Assistant he was again diverted to Branch Office Guindy. The wife of Shri A. Arulprasath, Assistant was promoted to the post of ANS in ESIC Hospital, K.K. Nagar and was transferred to ESIC Hospital Tirunvalveli in midsession without giving her retention in current session. Thus there are two violation detected in transfer policy :
- a) Transfer was ordered in midsession.
 - b) When Husband and wife both are working they will be adjusted in same station.
- iv) Smt. J. Daisy, MTS, in Branch Office Poonamallee a compassionate appointee had undergone surgery in the brain was transferred to Branch Office Guindy which is far off place to earlier place of posting and after posting also she had undergone a surgery in her throat (Thyroid) and continuously creating hostile working environment in her workplace by frequently issuing Memos.
- v) Shri G. Nagarajan, Treasurer of Regional Association was transferred against all transfer policies as he was neither first person placed in the Region nor last person placed in the Region in his cadre.
- vi) Shri V. Renjith, Assistant Treasurer of Regional Association was also transferred on similar fashion.
- vii) Smt. Manjuparkavi, Smt. Prabhavathy, Shri Karthikeyan Arasu, Sri M. Chelliya were also harassed and their transfer request for repatriation has not been considered in spite of direction of Hon'ble Minister.

9. Here, I am also made to believe that Shri Balamani Sankar, General Secretary of General Union was facing investigation in matter of a complaint under the Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act 2013 for creating hostile working environment in Regional Office, Tamilnadu for one of our staff and as per the relevant act he was supposed to be removed from Regional Office.

10. It is also understood that as per the transfer policy for Group A & B Officers in ESIC maximum tenure for any Officer posted in Regional Office is 3 years and at one station is 6 years. Since, Shri R. Suresh, Deputy Director (Admn.) in Regional Office, Chennai had completed his maximum tenure of 3 years and rather he had exceeded his maximum tenure by over two years he may immediately be transferred out of the Region.

11. In view of above, it is quite clear that corrupt practices manifests in all above actions of management and the need of occasion warrants following actions and intervention in these matter by your good office :

- i) For free and fair implementation of direction of Hon'ble Minister of State and allowing the aggrieved person posting near to his toddler daughter who is just two years old and for immediate release of his salary.
- ii) For taking action against all those who are involved in this kind of discrimination and violation of policies/guidelines/norms.
- iii) For issuing direction to re-investigation complaint in the case of Shri Balamani Sankar, General Secretary of General Union under the Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act 2013 and his removal from Regional Office as his clear collusion with management is established in workplace and Dr. Indra of ESIC Hospital, K.K. Nagar is told to be close to the RD & AC, Chennai.
- iv) For immediate transfer of Shri R. Suresh, Deputy Director (Admn.) from Regional Office Chennai to some other Region as he has completed his maximum tenure of 3 years in RO and is also due to complete his maximum tenure of 6 years in a Region.

Since, the matter is of serious nature, an urgent action is solicited.

Sub: Moratorium on rotational transfers of officers/staff in view of COVID-19 Pandemic.

In view of the extraordinary situation prevailing in the country due to outbreak of COVID-19 Pandemic causing serious disruptions in the life, it would not be appropriate to dislocate officers/staff of Ministry of Labour & Employment/its attached offices/subordinate offices/autonomous organisations for one year. Therefore, it is directed that no rotational transfers of officers/officials in different grades (Group 'A', 'B' and 'C') be carried till 30.04.2021 in Ministry of Labour & Employment, ESIC, EPFO, CLC(C), DGLW, VVGNI, DGMS, DGFASLI, Labour Bureau etc. The exception to the moratorium on rotational transfers upto 30.04.2021 would be on following grounds:-

- (i) Administrative reasons to fill any vacancy due to promotion/retirement with general principles that minimum dislocation is caused to the officers/staff while deciding postings on promotion.
- (ii) Consideration of requests by officers/staff on compassionate grounds i.e. medical emergency with self or family members etc. However, the transfers being made on personal request and on compassionate ground will be without any cost to the Government i.e. no transfer grants/transfer allowance/travelling allowance would be paid to the officers/staff who have been transferred on their own request.

2. The transfer to be made in the above two categories would be recommended by the Transfer Committees and the transfer orders would be issued after the approval of the competent authority. These directions would come into effect with immediate effect and the necessary orders may be issued by different organisations accordingly. This step would lead to minimum inconvenience at this point of time of COVID-19 and would also curtail the expenditure of Government during this financial year.

5. The action of Regional Director, RO, Chennai regarding non-considering the request of aggrieved applicant is grossly in appropriate and against the spirit of policy approved by Hon'ble Minister of State for Labour and Employment and Chairman of Apex Body of ESIC and DG, ESIC.
6. Further to above, I have also been made to understand that the Officer In-charge of SRO Madurai had not disbursed the salary of aggrieved applicant for the month of June, 2020 during this covid -19 distress.
7. ESIC Headquarters have issued a letter bearing No. D/36/11/ARM/2018-Genl. Dated 15-05-2020 (Annexure - V) wherein the approval of DG, ESIC was communicated for payment of salary / wages to contractual manpower such as housekeeping, maintenance etc. deployed in the ESIC offices who could not attend the office due to either closure of office or lockdown measures implemented by the Government of India / State Government.
8. In this regard, I had tried to invite attention of Additional Commissioner and Regional Director, RO, Chennai on above facts and for compliance of orders of Minister of I&E and DG, ESIC vide my letter bearing No. AIESIC.SC/ST.FED.2015-072 dated 02nd July 2020 (Annexure- VI) for speedy action in the matter but yet no action is forthcoming.

9. Madam, during this period of Pandemic COVID 19, the applicant is in Pandemic hardship. Hence, you are requested to direct the Regional Director, Tamilnadu for following urgent actions:

1. Immediate release of salary of aggrieved person for the months of June, 2020 as such kind of punitive action cannot be done arbitrarily.
2. Immediate consideration of requests of aggrieved member for retention at their present place of posting.
3. Allowing all other officials to work from home where the officials concerned are not able to attend office due to various guidelines issued by DoP&T (GoI), Ministry of Home Affairs (GoI), Concerned State Government and local Authorities due to lockdown, declaration of their residence as containment zone or social distancing, etc. as per GoI guidelines.

Since, the matter is of serious nature, an urgent action is solicited.



Sub: Moratorium on rotational transfers of officers/staff in view of COVID-19 Pandemic.

In view of the extraordinary situation prevailing in the country due to outbreak of COVID-19 Pandemic causing serious disruptions in the life, it would not be appropriate to dislocate officers/staff of Ministry of Labour & Employment/its attached offices/subordinate offices/autonomous organisations for one year. Therefore, it is directed that no rotational transfers of officers/officials in different grades (Group 'A', 'B' and 'C') be carried till 30.04.2021 in Ministry of Labour & Employment, ESIC, EPFO, CLC(C), DGLW, VVG NLI, DGMS, DGFASLI, Labour Bureau etc. The exception to the moratorium on rotational transfers upto 30.04.2021 would be on following grounds:-

- (i) Administrative reasons to fill any vacancy due to promotion/retirement with general principles that minimum dislocation is caused to the officers/staff while deciding postings on promotion.
- (ii) Consideration of requests by officers/staff on compassionate grounds i.e. medical emergency with self or family members etc. However, the transfers being made on personal request and on compassionate ground will be without any cost to the Government i.e. no transfer grants/transfer allowance/travelling allowance would be paid to the officers/staff who have been transferred on their own request.

2. The transfer to be made in the above two categories would be recommended by the Transfer Committees and the transfer orders would be issued after the approval of the competent authority. These directions would come into effect with immediate effect and the necessary orders may be issued by different organisations accordingly. This step would lead to minimum inconvenience at this point of time of COVID-19 and would also curtail the expenditure of Government during this financial year.

In view of the extraordinary situation prevailing in the country due to outbreak of COVID-19 Pandemic causing serious disruptions in the life, it would not be appropriate to dislocate officers/staff of ESI Corporation for one year. It has, therefore, been decided that:

- 1- No rotational transfers of officers/officials in different grades (Group 'A' 'B' and 'C') be carried till 30.04.2021.
- 2- The exception to this moratorium on rotational transfers, would, however, be administrative reasons to fill up any vacancy due to promotion/retirement and consideration of requests by officers/staff on compassionate grounds i.e. medical emergency with self or family members etc with general principles that minimum dislocation is caused to the officers/officials while deciding postings on promotion.
- 3- Transfers being made on personal request and on compassionate ground will be without any cost to the government i.e. no transfer grants/transfer allowance/travelling allowance/daily allowance would be paid to the officers/staff who have been transferred on their own request
- 4- The transfer to be made in the above categories i.e. Para 2 would be recommended by the Transfer Committee.

This is in compliance to directions received from Government of India and meets approval of competent authority. All the immediate cadre controlling authorities are advised to circulate & bring contents of this O.M. to knowledge of all the concerned of their respective units.

Subject : Payment of salary/wages to contractual manpower for the period of lockdown

Madam / Sir,

As you are aware that our country is combating with the threat of COVID-19 and Government of India took several measures starting first week of March 2020 for containing the spread of this pandemic. One among these measures, undertaken for this purpose, was complete lockdown declared by Government of India effective from 25.3.2020. Vide MHA order dated 24.3.2020, offices of the Government of India, its Autonomous / Subordinate offices were closed down in the country bearing few exceptions wherein essential services were allowed to be continued. Gradually, based on the detection of COVID-19 positive cases, containment zones / zones were identified in cities/districts and those areas were sealed for any movement to contain the spread of virus.

Department of Expenditure, Ministry of Finance issued directions vide OM No. 23(4)/E. Coord / 2020/1 dated 23.3.2020 stating that due to complete lockdown measures, there is a likelihood of a number of contractual, casual and outsourced staff such as housekeeping staff etc. being required to stay at home, which under normal circumstances would result in deduction in their pay / wages. In order to avoid any undue hardship under the prevailing extraordinary circumstances, it has been decided that whenever any such contractual, casual and outsourced staff of Ministries / Departments and other organizations of Government of India is required to stay at home in view of lockdown orders regarding COVID-19 prevention, as announced by various States / UT Governments, they shall be treated as "on duty" during such period of absence and necessary pay / wages would be paid accordingly.

In view of above, I am directed to inform that DIRECTOR General has accorded approval for

payment of salary / wages to contractual manpower such as housekeeping, maintenance etc. deployed in the ESIC offices who could not attend the office due to either closure of office or lockdown measures implemented by Government of India / State Governments. However, it may be ensured that the strength of contractual employees will remain same which was prevailing as on 24.3.2020 i.e. only those employees will be paid who were under deployment as on the date of declaration of lockdown. In case of ESIC Hospitals which are functioning during the lockdown period being essential services, the payment of wages may be made on the basis of attendance since manpower working in hospitals are supposed to perform duties during this period also. Only those contractual employees of hospitals can be considered on duty for payment of wages whose residential areas were sealed as containment zone and no movement was allowed in those areas due to which they could not attend their duties.
