Respected Madam,

- 1. With due regard, I would like to invite your kind attention on enclosed note issued under kind signature of Hon'ble Minister of State for Labour & Employment, Govt. of India dated 20-05-2020 with subject captioned as "Moratorium on rotational transfer of officers/staff in view of COVID-19 pandemic-regarding" (Annexure-I). Wherein, it is clearly directed "that no rotational transfers of officers/officials in different grades (Group 'A', 'B' and 'C') be carried till 30.04.2021 in Ministry of Labour & Employment, ESIC, EPFO, CLC(C), DGLW, VVGNLI, DGMS, DGFASLI, Labour Bureau etc. except consideration of requests by officers/staff on compassionate grounds i.e. medical emergency with self or family members etc."
- 2. In this regard, I would also like to invite your kind attention on ESIC Hqrs Office has also issued Office Memo. No. A-22/13(T)/2020-Med-VI (Covid-19) dated 04th June, 2020 with subject "Moratorium on rotational transfer of officers/staff in view of COVID-19 pandemic-regarding" (Annexure-II). It clearly states that, "in view of the extraordinary situation prevailing in the country due to outbreak of COVID-19 Pandemic causing serious disruptions in the life, it would not be appropriate to dislocate officers/staff of ESI Corporation for one year. It has, therefore, been decided that transfer being made on personal request and on compassionate ground will be without any cost to the Govt. i.e. no transfer grant/transfer allowance/travelling allowance/daily allowance would be paid to the officers/staff who have been transferred on their own request."

- 3. Here, I would like to submit that I have received one representation from Shri Ghanshyam Meena, Social Security Officer, Branch Manager, Branch Office, Bhawani Mandi (**Annexure III**) which was duly forwarded to the Regional Director, Jaipur vide my letter of even number dated 18-07-2020 (**Annexure IV**) for necessary action.
- 4. The representation of Shri Ghanshyam Meena consists of following facts:
 - i. The applicant Shri Ghanshyam Meena, Branch Manager/SSO was discriminately posted to Branch Office, Bhawani Mandi 400 Kms from Jaipur contrary to policy adopted; however, in compliance he joined there.
 - ii. A total of 12 persons were given regular promotion to the post of SSO and allocated Jaipur Region. Out of these 12 person all 11 General Category SSOs were adjusted in same station/places adjoining to same station and Shri Ghanshyam Meena, the lone SSO belonging to ST Category was directed to join in Bhawani Mandi which is around 400 Kms from Jaipur.
 - iii. The applicant made a representation dated 01.07.2020 and endorsed a copy of same to undersigned.
 - iv. I am made to understand from his ultra sound reports that the applicant is suffering from disease of carrying cysts in his both kidneys.
 - v. Because of this posting in small city he is not able to get proper treatment.
 - vi. Further due to various kind of restriction on moving and requirement of quarantine after movement the applicant is facing life threatening situations.
 - vii. Since, the applicant has to visit Jaipur for seeking treatment of his diseases. His landlord is also asking him to vacate his residence.
- 5. Madam, during this period of Pandemic COVID 19, the applicant is in Pandemic Hardship. Hence, you are requested to kindly direct the Regional Director to consider request of **Shri Ghanshyam Meena, Social Security Officer, Branch Manager, Branch Office, Bhawani Mandi** for immediate transfer to any ESIC office in Jaipur, Rajasthan.

An early action in the matter will be highly appreciated.

Sub: Moratorium on rotational transfers of officers/staff in view of COVID-19 Pandemic.

In view of the extraordinary situation prevailing in the country due to outbreak of COVID-19 Pandemic causing serious disruptions in the life, it would not be appropriate to dislocate officers/staff of Ministry of Labour & Employment/its attached offices/subordinate offices/autonomous organisations for one year. Therefore, it is directed that no rotational transfers of officers/officials in different grades (Group 'A', 'B' and 'C') be carried till 30.04.2021 in Ministry of Labour & Employment, ESIC, EPFO, CLC(C), DGLW, VVGNLI, DGMS, DGFASLI, Labour Bureau etc. The exception to the moratorium on rotational transfers upto 30.04.2021 would be on following grounds:-

- (i) Administrative reasons to fill any vacancy due to promotion/ retirement with general principles that minimum dislocation is caused to the officers/staff while deciding postings on promotion.
- (ii) Consideration of requests by officers/staff on compassionate grounds i.e. medical emergency with self or family members etc. However, the transfers being made on personal request and on compassionate ground will be without any cost to the Government i.e. no transfer grants/transfer allowance/travelling allowance would be paid to the officers/staff who have been transferred on their own request.
- 2. The transfer to be made in the above two categories would be recommended by the Transfer Committees and the transfer orders would be issued after the approval of the competent authority. These directions would come into effect with immediate effect and the necessary orders may be issued by different organisations accordingly. This step would lead to minimum inconvenience at this point of time of COVID-19 and would also curtail the expenditure of Government during this financial year.

- 1- No rotational transfers of officers/officials in different grades (Group 'A', 'B' and 'C') be carried till 30.04.2021.
- 2- The exception to this moratorium on rotational transfers, would, however, be administrative reasons to fill up any vacancy due to promotion/retirement and consideration of requests by officers/staff on compassionate grounds i.e. medical emergency with self or family members etc with general principles that minimum dislocation is caused to the officers/officials while deciding postings on promotion.
- 3- Transfers being made on personal request and on compassionate ground will be without any cost to the government i.e. no transfer grants/transfer allowance/travelling allowance/daily allowance would be paid to the officers/staff who have been transferred on their own request.
- 4- The transfer to be made in the above categories i.e. Para 2 would be recommended by the Transfer Committee.

This is in compliance to directions received from Government of India and meets approval of competent authority. All the immediate cadre controlling authorities are advised to circulate & bring contents of this O.M. to knowledge of all the concerned of their respective units.

उक्त विषय में निवेदन है कि मुझे मुख्यालय के आदेश संख्या 200 दिनांक 28.11.2019 के अनुसार क्षेत्रीय कार्यालय जयपुर राजस्थान में तैनाती के आदेश प्रदान किए गए थे। वर्ष 2010-2011 से मुख्यालय ने जिस भी कर्मचारी को क्षेत्रीय कार्यालय जयपुर दिया गया उन सभी कर्मचारियों को क्षेत्रीय कार्यालय जयपुर में जॉड़निंग करवाई गयी है। रोटेशन के तहत उनका स्थानांतरण किया गया था।

मुख्यालय आदेश दिनांक 28.11.2019 के अनुसार 12 कर्मचारियों को क्षेत्रीय कार्यालय जयपुर राजस्थान दिया गया जिसमें से 11 कर्मचारियों को क्षेत्रीय कार्यालय जयपुर में जॉड़निंग करवाई गयी एवं एक मात्र मुझे शाखा कार्यालय भवानीमंडी में तैनाती के आदेश प्रदान किए गए जो नियमानुसार सही नहीं है फिर भी मैंने आपके कार्यालय आदेश संख्या 233(ई) दिनांक 04.12.2019 की अनुपालना करते हुए शाखा कार्यालय भवानीमंडी में दिनांक 04.12.2019 को कार्य ग्रहण कर लिया था।

श्रीमान मै आपका ध्यान मेरी स्वास्थ्य, कोरोना वाइरस एवं पारिवारिक समस्या की ओर आकर्षित करना चाहता हू जो कि निम्नानुसार है:-

शीमान मेरी दोनों किडिनियों में सिस्ट है जिसकी वजह से मुझे हाइ ब्लड प्रेशर रहता है तथा कभी कभी मुझे अचानक पेट में बहुत तेज़ दर्द होता है एवं पेशाब बंद हो जाता है। एसी परिस्थितियों में मेरा अकेला रहना बहुत मुश्किल है। मुझे दिनांक 26.05.2020 को अचानक पेट में बहुत तेज़ दर्द हुआ मैंने भवानीमंडी में आर के हॉस्पिटल में दिखाया जिसमे मुझे दवाइया दी जिसको लेने के बाद मेरे पैरो एवं चेहरे पर सूजन आ गया एवं अधिक समस्या हो गयी थी तथा बड़ी मुश्किल से मैंने रात निकाली। भवानीमंडी में कोई भी किडनी विशेषज्ञ नहीं है जिसे

मै दिखा सकु। मै दिनांक 27.05.2020 को भवानीमंडी से जयपुर के लिए रवाना हुआ लोक डाउन में साधन भी उपलब्ध नहीं था बड़ी मुश्किल से जयपुर आया एवं सवाई मानसिंह चिकित्सालय के नेफ़ोलोजी विभाग अध्यक्ष डा. विनय मल्होत्रा को दिखाया उन्होंने जाँच करवाकर मुझे दवाई दी जिसमें मुझे आराम आया जिसकी सूचना मैंने आपके कार्यालय को दी डा. जाँच पर्ची भी संलग्न है। मुझे मेरे स्वास्थ्य को ठीक रखने के लिए डा. विनय मल्होत्रा किडनी विशेषज्ञ कि देख रेख में रहना अति आवश्यक है तथा भवानीमंडी में कोई किडनी विशेषज्ञ नहीं है। एवं जयपुर आने के लिए 7-8 घंटो का समय लगता है। जो कोरोना वाइरस कि वजह से साधन उपलब्ध नहीं अतः मेरा स्थानांतरण जयपुर या जयपुर के आस पास होना अति आवश्यक है जिससे मैं समय रहते डा. विनय मल्होत्रा को दिखा सकु।

- 2 मेरी धर्मपत्नी राजस्थान के शिक्षा विभाग में प्रधानाचार्य के पद पर राजकीय उच्च माध्यमिक विध्यालय उगरियवास जयपुर में नियुक्त है। केंद्र सरकार के नियमानुसार पित पत्नी दोनों सरकारी सेवा मे कार्यरत है तो एक जगह रहने का प्रावधान है। अतः श्रीमान मुझे क्षेत्रीय कार्यालय जयपुर मे नियुक्त करने का श्रम करे जिससे अपने अपने कार्यालयों मे सही ढंग से कार्यों का निर्वाह कर सके।
- 3 मेरी बच्ची महारानी कॉलेज प्रथम वर्ष एवं बच्चा JECRC कॉलेज जयपुर सीतापुर में अध्ययन कर रहे हैं। मुझे बच्चों की देख भाल के लिए भवानीमंडी से जयपुर समय समय पर आना होता है। भवानीमंडी से जयपुर लगभग 400 किमी दूर है। एवं सफर में 7-8 घंटों का समय लगता है। कोरोना वाइरस की वजह से भवानीमंडी से साधन भी उपलब्ध भी नहीं है। एक मात्र मुंबई सेंट्रल ट्रेन चलती है। जिसमें भी रिजर्वेशन मिलना मुश्किल होता है। रिजर्वेशन के बिना यात्रा करना संभव नहीं है। मुंबई सेंट्रल ट्रेन में कोरोना से संक्रमित होने की संभावना अधिक है। मैं किडनी रोग से ग्रस्त हू कोरोना वाइरस से यदि किडनी रोगी संक्रमित हो गया तो उसका बचना मुश्किल है। भारत सरकार, मुख्यालय द्वारा कोरोना वाइरस संक्रमण से बचाव के लिए रोगग्रस्त एवं विकलांग कर्मचारियों का विशेष ध्यान रखने के दिशा निर्देश दिये गए है। अतः श्रीमान से मुझे कोरोना संक्रमित होने से बचाना है तो जयपुर स्थानांतरण करना अति आवश्यक है।
- 4 मैं मुंबई सेंट्रल से भवानीमंडी जाता हू। भवानीमंडी रेल्वे स्टेशन पर सभी यात्रियों के फोन नंबर एवं पता नोट कर लिया जाता है। कहा से आए है एवं किस स्थान पर जाना है। फिर वहा पर डॉक्टर एवं आशा सहयोगिनी बताए पते पर पाहुच कर होम आइसोलेशन का दबाव बनाया जाता है। होम आइसोलेशन होने के बाद नियमानुसार घर से बाहर नहीं जा सकता हू एवं मेरे खाने पीने की वस्तुओं का

समान कैसे आएगा। शाखा कार्यालय भी नहीं जा सकता हू इससे कार्यालय का कार्य भी बाधित होता है।

5 मकान मालिक जिसके मैंने मकान किराए पर ले रखा है। वह मकान खाली करवाने का दबाव बना रखा है। एवं कहता है कि जयपुर में अधिक कोरोना संक्रमित लोग है आप मकान खाली कर दो एवं जयपुर से आने वालों को नया मकान मालिक मकान किराए पर देने के लिए तैयार नहीं होता है।

उपर्युक्त परिस्थितियों के कारण मैं मानसिक रूप से परेशान चल रहा हू। अतः श्रीमान से निवेदन है कि मेरी परिस्थितियों को ध्यान में रखते हुए मारे प्रार्थना पत्र पर सहानुभूतिपूर्वक विचार करते हुए जयपुर में स्थानांतरण करने की कृपा करे। आपकी अति कृपा होगी। जीवन भर इस कार्य के लिए आपका आभारी रहूँगा।

Multiple tiny echogenic foci seen in renal parenchyma. Calculus of approx 5-6 mm seen in lower calyx. Evidence of mild hydronephrosis & hydroureter seen. Calculus of approx 8.1 mm seen in VUJ.

Urinary bladder is well distended. Wall thickness is normal. No calculi or mass seen. Prostate is not enlarged. (Vol. 17 'cc) No free fluid seen.

 20-05-2020 with subject captioned as "Moratorium on rotational
 transfer of officers/staff in view of COVID-19 pandemicregarding" (Annexure-I). Wherein, it is clearly directed "that no
 rotational transfers of officers/officials in different grades (Group
 'A', 'B' and 'C') be carried till 30.04.2021 in Ministry of Labour &
 Employment, ESIC, EPFO, CLC/C), DGLW, VVGNLI, DGMS,
 DGFASLI, Labour Bureau etc. except consideration of requests by
 officers/staff on compassionate grounds i.e. medical emergency
 with self or family members etc."
- 2. In this regard, I would also like to invite your kind attention on ESIC Hars Office has also issued Office Memo. No. A-22/13(T)/2020-Med-VI (Covid-19) dated 04th June, 2020 with subject "Moratorium on rotational transfer of officers/staff in view of COVID-19 pandemic-regarding" (Annexure-II). It clearly states that, "in view of the extraordinary situation prevailing in the country due to outbreak of COVID-19 Pandemic causing serious disruptions in the life, it would not be appropriate to dislocate officers/staff of ESI Corporation for one year. It has, therefore, been decided that transfer being made on personal request and on compassionate ground will be without any cost to the Govt. i.e. no transfer grant/transfer allowance/travelling allowance/daily allowance would be paid to the officers/staff who have been transferred on their own request."

- Here, I would like to submit that I have received one representation from Shri Ghanshyam Meena, Social Security Officer, Branch Manager, Branch Office, Bhawani Mandi (Annexure - III).
- The representation of Shri Ghanshyam Meena consists of following facts:
 - The applicant Shri Ghanshyam Meena, Branch Manager/SSO was discriminately posted to Branch Office, Bhawani Mandi 400 Kms from Jaipur contrary to policy adopted; however, in compliance he joined there.
 - ii. A total of 12 persons were given regular promotion to the post of SSC and allocated Jaipur Region. Out of these 12 person all 11 General Category SSOs were adjusted in same station/places adjoining to same station and Shri Ghanshyam Meena, the lone SSO belonging to ST Category was directed to join in Bhawani Mandi which is around 400 Kms from Jaipur.
 - The applicant made a representation dated 01.07.2020 and endorsed a copy of same to undersigned.
 - I am made to understand from his ultra sound reports that the applicant is suffering from disease of carrying cysts in his both kidneys.
 - v. Because of this posting in small city he is not able to get proper treatment.
 - vi. Further due to various kind of restriction on moving and requirement of quarantine after movement the applicant is facing life threatening situations.
 - vii. Since, the applicant has to visit Jaipur for seeking treatment of his diseases. His landlord is also asking him to vacate his residence.
- 5. Sir, during this period of Pandemic COVID 19, the applicant is in Pandemic Hardship. Hence, you are requested to kindly consider request of Shri Ghanshyam Meena, Social Security Officer, Branch Manager, Branch Office, Bhawani Mandi for immediate transfer to any ESIC office in Jaipur, Rajasthan, failing which the matter will be taken up at other platforms.

An early action in the matter will be highly appreciate.
