Subject: **Non-Issuance of Vetted Charge-sheets by Regional Director, Kolkata for illegal considerations.**

Respected Sir,

With due regard, I would like to bring to your kind notice that on 08-07-2014 one of our member who was holding charge of Regional Director of Regional Office, Kolkata was misbehaved, subjected to abuse, illegally gheraoed and illegally detained in his office beyond office hours by certain office bearers of ESIC Employees' Union, West Bengal.

The draft charge sheet of five culprits was referred to Headquarter Vigilance for vetting. The same was reported to have been forwarded to present Regional Director after it is vetted by the Headquarter Vigilance.

It has come to our notice that the Regional Director had returned these charge sheet to Headquarters Office (E-II) for delaying the issuance of these charge sheets. The CVC has laid down time limit for completing the departmental enquiry as six months, but in this case the issuance of charge sheet in itself has been delayed by five month.

Apart from above, it is also informed that the Regional Director in order to harass one of our member Shri Debasish Barua, posted him in Siliguri and has not repatriated him in contravention of existing norms of rotation policy of officers.

Further to above, it is also informed to me that the Regional Director had hired a Car for purpose of use of Recovery Officer and Recovery Inspector inspite of the fact that two official cars are already available with RD and SMC which can be spared for Recovery purpose

It seems that the two official cars are well regulated by official driver and driver's log book and hence there is no scope for manipulation in them. The alternate option available with Regional Director was to hire a private car in name of Recovery Officer and Recovery Inspector. This alternate vehicle is put to misuse. It is also informed by some sources that this vehicle is being used for wrong purposes also. The Regional Director, Kolkatta is reported to be using this vehicle to visit Mohan Bagan Club for late night drink sessions.

In view of above facts you are requested to kindly do the needful to sensitize the corrupt officers and also issue necessary direction to do the needful action against charged officers as per the period schedule issued by CVC as the departmental proceeding had already been delayed.
