Sub : Review/Regular DPC – Promotion to the post of Assistant Director/Section Officer/ Manager Grade-I in the Employees State Insurance Corporation.

Sir,

I am directed to refer to your letter No.A-33/13/1/2008-E.1 dated 28.09.2011 on the above subject and to forward herewith two copies of the minutes of the above mentioned DPC held in this office on 30th September, 2011 and 3rd to 5th October, 2011 duly signed by the Chairman and Members of the DPC.

2. The Commission have also approved the recommendations of the DPC as contained in the minutes of the DPC.


3. Attention of Ministry/Department is also invited to the instructions contained in para 6.4.4 of the DOP&T O.M. No.22011/5/86-Estt. (D) dated 10th April, 1989, which provide that promotions will have only prospective effect even in cases where the vacancies relate to earlier year(s). Para 17.11 of the said O.M. further provides the date from which the promotion should take effect. These instructions may be kept in view by the Ministry/Department while implementing the recommendations of the DPC, unless otherwise prescribed in the statutory RRs or directed by the Court of Law or in case of Review DPC.

4. It has been observed that in many of the cases received by the Commission the Recruitment Rules relevant to the concerned post had been framed long ago. In the accordance with the DOP&T O.M. No. 14017/12/87-Estt.(RR), dated 18th March, 1988, the Recruitment Rules are required to be reviewed and amended by following prescribed procedure wherever necessary, by the Administrative Ministries/Departments once in every five years. The Ministry/Department is accordingly required to review the relevant Recruitment Rules in terms of the said instructions expeditiously, under intimation to this office.



ITEM-I : Review DPC – Selection of officers for officiating promotion to the post of Assistant Director/Section Officer/Manager Grade-I {Group 'B'; Scale of pay: Rs.6,500-10,500 (pre-revised)} for the vacancy year 2008-09 in the Employees' State Insurance Corporation.

The Review Departmental Promotion Committee were informed that the recommendations of the regular DPC held from 7th to 10th December, 2009 for promotion to the post of Assistant Director/Section Officer/Manager Grade-I in the Employees' State Insurance Corporation against the vacancy year 2008-09 is required to be reviewed in view of the revised vacancy position in that year.

2.1. A meeting of regular DPC was held in the Commission's office from 7th to 10th December, 2009 for reframing panel against the vacancies pertaining to year 2004-05 and preparation of year-wise panels against the regular vacancies from 2005-06 to 2008-09 for promotion of officers to the post of Assistant Director/Section Officer/Manager-Gr.I (Group 'B' post) in the Employees' State Insurance Corporation. The said DPC, interalia, took into account 14 vacancies (08 General & 06 SC vacancies) for the year 2008-09. It has now been intimated by the Department that in addition to the earlier mentioned 14 vacancies, 07 (General) more vacancies had actually arisen during the year 2008-09 which could not be intimated inadvertently to the DPC held in December, 2009. The Department has, therefore, requested the Commission for convening a Review DPC meeting to review the proceedings of the Regular DPC

in respect of panel year 2008-09 only. Thus the revised number of vacancies for the vacancy year is 21 (15 UR and 06 SC). Hence the Review DPC.

2.2 The Review Committee decided to adopt the same grading as assigned by the Regular DPC held in December, 2009 in respect of those officers who were already assessed against the vacancies pertaining to the year 2008-09 and assessed the suitability in respect of remaining officers afresh whose names have been included in the revised eligibility list as indicated **Annexure-I**.

3.1. On the basis of the assessment as given in **Annexure-I**, the Review Committee recommend that the revised panel for officiating promotion to the post of Assistant Director/Section Officer/Manager Grade-I against the 21 vacancies in the Employees' State Insurance Corporation should consist of the officers mentioned in **Annexure-II** in the order stated therein.

3.2. The recommendations of the Regular DPC held in December, 2009 shall stand amended to the extent indicated in para 3.1 above.

ITEM-II : DPC – Selection of officers for officiating promotion to the post of Assistant Director/Section Officer/Manager Grade-I {Group 'B'; Scale of pay: Rs.6,500-10,500 (pre-revised)} in the Employees' State Insurance Corporation.

The Departmental Promotion Committee considered the question of selection of officers for officiating promotion to the post of Assistant Director/Section Officer/Manager Grade-I in the Employees' State Insurance Corporation.

2. The vacancy position, as intimated by the Employees' State Insurance Corporation to the DPC, is as under:

3. The Departmental Promotion Committee were informed of the following provisions contained in the DPC guidelines, circulated by the Department of Personnel and Training, vide their O.M. No. 22011/5/86-Estt.(D) dated 10.04.1989:-

- (i) "6.1.2. – The DPC enjoy full discretion to devise their own methods and procedures for objective assessment of the suitability of candidates who are to be considered by them".



- (ii) "6.1.3. – While merit has to be recognized and rewarded, advancement in an officer's career should not be regarded as a matter of course, but should be earned by dint of hard work, good conduct and result oriented performance as reflected in the ACRs and based on strict and rigorous selection process".
- (iii) "6.2.1 (b) – The DPC should assess the suitability of the officers for promotion on the basis of their service record and with particular reference to the CRs for preceding five years, which became available during the year immediately preceding the vacancy/panel year."
- (iv) "6.2.1(e) – The DPC should not be guided merely by the overall grading, if, any, that may be recorded in the CRs but should make its own assessment on the basis of entries in the CRs, because it has been noticed that some times the overall grading in a CR may be inconsistent with the grading under various parameters or attributes".
- (v) "6.2.1(f) - If the Reviewing authority or the Accepting authority as the case may be has overruled the Reporting Officer or the Reviewing authority as the case may be, the remarks of the latter authority should be taken as the final remarks for the purposes of assessment provided it is apparent from the relevant entries that the higher authority has come to a different assessment conclusively after due application of mind. If the remarks of the Reporting Officer, Reviewing authority and Accepting authority are complementary to each other and one does not have the effect of overruling the other, then the remarks should be read together and the final assessment made by the DPC."
- (vi) In cases where adverse remarks of reporting/reviewing/accepting authorities have been expunged or modified by the competent authority, the overall grading in the ACR has been decided by the DPC in terms of DOP&T O.M. dated 06.01.2010.
- (vii) The Committee were also apprised that the DOP&T vide O.M. No.21011/1/2010-Estt-A dated 13th April, 2010 have stipulated that "if an employee is to be considered for promotion in a future DPC and his ACRs prior to the period 2008-09 which would be reckonable for assessment of his fitness in such future DPCs

contain final grading which are below benchmark for his next promotion, before such ACRs are placed before the DPC, the concerned employee will be given a copy of the relevant ACR for his representation, if any, within 15 days of such communication

- (viii) Where Competent Authority has upgraded/downgraded the overall grading without giving sufficient reasons, such an exercise has been treated as non-est/invalid in terms of DOP&T O.M. dated 06.01.2010.

4. The Committee were also informed that in accordance with the instructions contained in para 6.3.1 of the DOP&T O.M. No. 22011/5/86-Estt(D) dated 10.04.1989, read with subsequent O.M. No. 22011/5/91-Estt(D) dated 27.03.1997 and O.M. No. 35034/7/97-Estt(D) dated 08.02.2002, the benchmark for promotion in the present case is "Good".

5. Attention of the Committee was also invited to the instructions contained in DOP&T O.M. No. 35034/7/97-Estt(D) dated 08.02.2002, which inter-alia provides that "the DPC shall determine the merit of those being assessed for promotion with reference to the prescribed benchmark and accordingly grade the officers as "Fit" or "Unfit" only. Only those who are graded "fit" (i.e. who meet the prescribed bench mark) by the DPC shall be included and arranged in the select panel in order of their inter-se seniority in the feeder grade. Those officers who are graded "unfit" (in terms of the prescribed bench mark) by the DPC shall not be included in the select panel. Thus, there shall be no supersession in promotion among those who are graded "fit" (in terms of the prescribed benchmark) by the DPC".

6. The Committee were apprised that taking into account the instructions/guidelines, issued by DOP&T, as detailed above, and in the absence of modalities of the benchmark being attained by the officers under consideration for promotion, the Commission in exercise of their constitutional functions as envisaged in Article 320 of the Constitution took a conscious decision that an officer attaining at least 4 bench mark gradings out of the 5 ACRs, should be assessed as "fit" for promotion and that this decision should be applicable to all DPCs pertaining to the vacancy year 2003-2004 and subsequent years.

7. The Departmental Promotion Committee, accordingly, examined the Character Rolls of the eligible officers and assessed them as stated in Annexure-I.
