(D) dated 10th April, 1989, which provide that promotions will have only prospective effect even in cases where the vacancies relate to earlier year(s). Para 17.11 of the said O.M. further provides the date from which the promotion should take effect. These instructions may be kept in view by the Ministry/Department while implementing the recommendations of the DPC, unless otherwise prescribed in the statutory RRs or directed by the Court of Law or in case of Review DPC.
- 4. The Ministry/Department is request that in the case of any officer who has been recommended for promotion by the DPC despite the imposition of penalty which was duly mentioned in the Department's proposal, such officers should be promoted only after the currency of the penalty period is over in terms of para 13 of the DOP&T Guidelines on DPCs as contained in O.M. No.22011/5/86-Estt.(D) dated 28.04.2014.

ITEM: Review DPC - Promotion to the post of Regional Director Gr.B / Joint Director (Group 'A'; Scale of pay of Rs.10,000-15,200 (pre-revised) in the Employees' State Insurance Corporation.

The Review Departmental Promotion Committee were informed that a meeting of DPC was held on 25th & 26th February, 2009 for considering promotion of officers to the post of Regional Director (Gr.B)/Joint Director in the Employees State Insurance Corporation against a total number of 98 vacancies pertaining to the years from 2004-05 to 2008-09. Thereafter, another meeting of the DPC was held on 24th September, 2010 for promotion to the same post against 09 vacancies of 2009-10. These DPCs were convened on the basis of Seniority List finalized on 09.06.2008

2.1 Subsequently, the Employees' State Insurance Corporation, vide their order dated 23.01.2012, revised the seniority list of the feeder post of Deputy Director in pursuance of the order dated 30.09.2010 passed by the Hon'ble Central Administrative Tribunal, Principal Bench, New Delhi in O.A.No.567/2009 filed by Shri M.K. Sharma & Others. By virtue of revision of seniority list, the interse-seniority position in respect of empanelled officers has changed. This had necessitated to review the recommendations of the above mentioned two regular DPCs only in respect of the vacancies of 2007-08, 2008-09 and 2009-10. Accordingly, a review DPC for the aforementioned three years was held on 30th July, 2012. Subsequent to the Review DPC, a DPC for the next vacancy year 2010-11 was also held on 12.07.2013 on the basis of the seniority list finalized on 23.01.2012.

- 2.2 Against the above decision of Hon'ble CAT, Shri Pranay Sinha, filed a R.A. No.95/2011 before Hon'ble CAT, which was dismissed by the Hon'ble CAT, Principal Bench by its order dated 04.07.11. Challenging the order dated 04.07.2011, Shri Pranay Sinha & Anr. filed a Writ Petition (C) No.5319 of 2011 before the Hon'ble High Court of Delhi.
- 3. The Hon'ble High Court of Delhi in WP (C) No.5319/2011 vide its order dated 30.09.2013 has ordered as under:-
 - (i) "The order dated 30th September, 2010 passed by the Central Administrative Tribunal is hereby modified only to the extent that the respondents shall re-consider the seniority list in the cadre of Deputy Directors in terms of para 29 of UOI and Ors. Vs. N.R. Parmar & Ors.
 - (ii) In case, the seniority list is not in compliance with the above directions, the respondents shall ensure that the seniority list is expeditiously drawn up in terms thereof.

The writ petition is disposed of in the above terms."

(The Hon'ble Supreme Court of India in the judgments dated 27.11.2012 in UOI & Ors. Vs. N.R. Parmar & ors. has held that the principles set out for fixation of seniority among promotes and direct recruits in the DOP&T O.Ms. dated 03.03.2008 must be deemed to be non-est as the same is in derogation of the earlier O.Ms. dated 07.02.1986 and 03.07.1986 containing principles/ guidelines for fixation of seniority.)

4. In compliance of the order of the Hon'ble High Court of Delhi in WP (c) No.5319/2011, Employees State Insurance Corporation vide its Speaking Order dated 04.03.2014 withdrew the seniority list of Dy. Directors finalized on 23.01.2012 and restored the seniority list of Dy. Directors finalized on 09.05.2008 with certain modifications. In view of the revision of the seniority list of feeder cadre i.e. Dy. Directors, the Department requested the Commission that the recommendations of the DPCs held earlier on 30.07.2012 and 12.07.2013 in respect of vacancy year 2007-08, 2008-09, 2009-10 and 2010-11 require to be reviewed again.

- 5. The Review Departmental Promotion Committee was also informed that the DPC which met on 12.07.2013 took into account 08 vacancies for the year 2010-11 as reported to it by ESIC. Although, there were 06 more vacancies for the same year but it could not be brought to the notice of the DPC inadvertently. The ESIC, therefore, also requested the Commission for framing a fresh panel against 14 vacancies for the year 2010-11 while reviewing the recommendations of the regular DPC, held on 12.07.2013. Hence, the Review DPC.
- The vacancy position for the four years is as follows:-

- 7. The Committee decided to adopt the same year-wise final grading given by the DPCs which met on 25th and 26th February, 2009 (Reviewed on 30.07.2012), 24.09.2010 and 12.07.2013 in respect of those officers finding place in the same vacancy year in which they were considered in the said DPCs and assess only those officers who are now finding a place in the eligibility list. The Committee, accordingly examined the relevant ACRs and assessed them as indicated against their names in **Annexure-I**.
- 8. On the basis of the assessment as given in Annexure-I, the Committee recommend that year-wise panel for promotion to the post of Regional Director Gr 'B' / Joint Director in the Employees' State Insurance Corporation should consist of the officers mentioned in Annexure-II in the order stated therein. The year-wise panels for 2007-08, 2008-09, 2009-10 and 2010-11 framed by the earlier DPCs, thus, stand modified to the extend indicated in Annexure-II herein.
