

**RECOMMENDATION OF TRANSFER COMMITTEE FOR ANNUAL
GENERAL TRANSFER FOR TRANSFER YEAR – '2026' IN RESPECT OF
OFFICERS IN THE CADRE OF JOINT DIRECTOR**

The Transfer Committee met in chamber of the Chairman, Transfer Committee on 20.03.2026 to consider the Annual General Transfer for the 'Transfer Year - 2026' in the cadre of Joint Director as per Transfer Policy dated 19.12.2024 through the online Transfer module.

Committee observed that Fifty-Three (53) requests have been received in the cadre of Joint Director. The committee deliberated on details of transfer request received from the officers, administrative requirements received from Divisional/ Zonal/ Regional heads with reference to the provisions of transfer/ posting policy. The committee adopted following criteria for recommendations in this cadre:

1. Organizational interest shall be given highest consideration for transfer and posting while considering any transfer, as stipulated in the relevant policy.
2. The Joint Director is a Group 'A' post having All-India Service Liability and officers posted on sensitive posts have been recommended for transfer, in pursuance of guidelines issued from time to time by the Central Vigilance Commission (CVC).
3. Given specialized operational demand of Headquarters where policy

related matters are dealt, some officers have been recommended for retention at/ transfer to ESIC HQ as per administrative requirements.

4. Officers who have not completed their minimum tenure of three years are not recommended for transfer, except in view of administrative requirement.

5. Officers who have completed their minimum tenure of three years are recommended for transfer as per their choice, subject to administrative feasibility.

6. Joint Directors are required to be posted in Medical Colleges in view of administrative requirement.

7. Officers who did not submit online transfer applications but have completed maximum tenure recommended for transfer as per provisions of the transfer policy.

8. In pursuance of directions issued by Hon'ble CAT, Chandigarh Committee also considered the request received from Sh. Ajay Kumar Mahan, Joint Director (U/t to ESICH&MC, PGIMSR, Rajajinagar from RO, Punjab). However, his request may not be considered, as officers are required at ESICH&MC, PGIMSR, Rajajinagar. And also, because officers are required to join their designated place of posting before submitting a transfer request. This is to ensure organizational interests are maintained and to avoid non-compliance with previously issued transfer orders.

Accordingly, recommendations and reasons thereon are being recorded by

the Transfer Committee based on past posting history of the officers and in administrative constraints.
